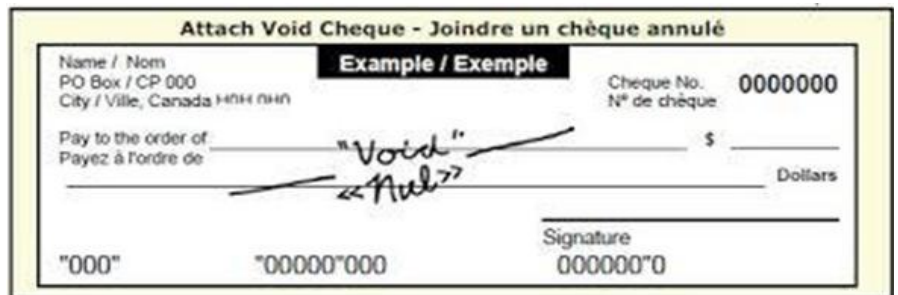

## 22. Summary of current regulations

1. Parking is always prohibited on the street and on the lawn.
2. Motorbike: use the shortest route from the park entrance to your home.
3. Speed: Anytime, anywhere 15 mph (25 km/h).
4. Electric vehicle (golf cart): driver 18 years of age and older.
5. Comply with signage.
6. Music and noise outside are prohibited from 10 p.m.
7. Construction prohibited on Saturdays, Sundays, and U.S. holidays.
8. Rental: the landlord is responsible for following up on payments by his tenants. Registration fees apply and forms must be completed.
9. The sticker for the main entrance must be permanently affixed to the windscreen of the vehicle. Remote control cannot be left to tenants. There is a \$25 fee for the purchase of the sticker. These fees may vary over time.
10. No towels, rugs, or other items on railings or balconies.
11. Out of respect and consideration for other residents, appropriate clothing (shirt, t-shirt, beach dress, etc.) must be always worn in public places and on the street. Bare-chested is forbidden everywhere, except at the swimming pool.
12. Garbage: Do not put garbage cans out before sunset the day before collection. Pick up garbage containers immediately after picking.
13. Swimming pool: take a shower before swimming, no hair washing, no pets, no alcoholic beverages, no glass containers and no being alone.
14. Hedges and fences are forbidden between the properties.
15. Trees: You must obtain a permit from the administration to plant or remove a tree.
16. Pets are not allowed for tenants.
17. Any violation of the regulations is punishable by a fine not exceeding \$1,000.00 per violation.
18. A long-term parking lot is available at a low cost on the site, for your vehicles that cannot be parked in your driveway (boat, trailer, motorhome, etc.) For more information, please contact the office.
